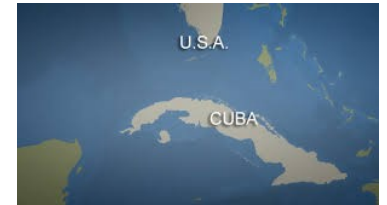

# UNPACKING RACISM ALONG WITH OTHER QUAKERS

Through my contact with the “unpacking racism” subcommittee of North Pacific Yearly Meeting’s (NPYM’s) committee on peace and social justice, I’ve learned that **Olympia Monthly Meeting (OMM)** would like to hold a workshop called **Undoing Institutional Racism (UIR)** sometime this spring. Unfortunately, no specific date has yet been set. The seminar will be put on by the 25-year-old, Bellevue (WA)-based People’s Institute NW: For Survival and Beyond. OMM is extending an invitation to Friends who would like to explore institutional racism, not unrelated to the fact that *unpacking systemic racism* will be the focus of the Friend in Residence at this year’s Annual Session.

Friends on the subcommittee who have already participated in a UIR workshop highly recommend it (and even consider re-taking it). Workshops strengthen or build community, create a visceral learning experience and in-depth understanding of systemic racism, and inspire engagement to create change. The UIR workshop will take place from a Friday evening to a Sunday afternoon.

Several folks who have already attended are sponsoring prospective attendees who haven’t the finances. As well, our South Mountain Ministry & Council has funds available to help with tuition and other expenses. It costs \$350 per participant. I plan on driving up to Olympia and participating and am open to carpooling.

## THE WORKSHOP ADDRESSES THE FOLLOWING AREAS:

**Analyzing Power** – Effective organizing requires accurate analysis of the systems that keep racism in place, why people are poor, how institutions perpetuate the imbalance of power, and who is responsible for maintaining the status quo.

**Defining Racism** – In order to undo racism, it must be understood. Organizers and educators who intend to build effective coalitions need to be very clear about what racism is and what it is not in order to avoid serious strategic and tactical errors.

**Understanding the Manifestations of Racism** – Racism operates in more than just individual and institutional settings. The dynamics of cultural racism, linguistic racism, and militarism as applied racism is examined.

**Learning from History** – Racism has distorted, suppressed and denied the histories of people of color and white people as well. An accurate knowledge of history is a necessary organizing tool as well as a source of personal and collective empowerment.

**Sharing Culture** – One of the most effective methods of oppression is to deny a people its history and culture. The training process strongly emphasizes “cultural sharing” as a critical organizing tool.

**Organizing to Undo Racism** – Community organizing principles are discussed in terms of how communities can achieve concrete results in dismantling the structures of racism.

# Meeting For Worship For Business: 18 February 2018

Present: Bill Ashworth (recording clerk), Melody Ashworth, Ken Deveney, Barbara Arrais, Crystal Bosbach (acting clerk), Anna Monders, Herb Rothschild

Meeting opened with worship. Clerk Crystal Bosbach read a passage she had recently written on active love.

Treasurer: Herb Rothschild reported that a November expense of \$117 had not been reported; this has been added to the cumulative expense amount reported this month. Income is running \$2266 ahead of expenses at this point, a reversal from last month's deficit. Our main checking account has over \$7600; overall, we have roughly \$25,700 in all accounts.

Peace and Social Concerns: Herb Rothschild asked if Peace and Social Concerns could be authorized to say "yes" to requests from Peace House to co-sponsor events in the name of the Meeting for Peace House's ongoing educational project regarding the UN Treaty to Prohibit Nuclear Weapons. Peace House is working with other organizations up and down the I-5 corridor on this.

**2018.2.1. The Meeting authorizes the Peace and Social Concerns Committee to sponsor and co-sponsor events in the name of the meeting regarding the UN Treaty to Prohibit Nuclear Weapons as the committee deems appropriate. Approved.**

The committee was asked to keep us apprised of these events.

Peace and Social Concerns asks anyone with suggestions for area organizations for the committee to donate to, to bring them forward. The emphasis should be on social change, rather than social service,

organizations. The committee plans to ask the Finance Committee to increase the amount appropriated for donations as they prepare the next Meeting budget. The aim is to tithe the Meeting's income (this would be approximately \$1400; the current budgeted amount is \$800).

## North Pacific Yearly Meeting:

Crystal reported that Annual Session will be July 25-29 at the University of Puget Sound in Tacoma. The Yearly Meeting has adopted a policy of "abundant financing"; attendees are asked to pay as much as they are able, instead of being charged a fixed amount. Requests and vetting are not required. Friends' presence at Annual Session is considered valuable to the Yearly Meeting. The theme is racial justice; the Friend in Residence will be Vanessa Julye. The Inclusivity Minute accepted last year will be examined in terms of possible implementations.

Ministry & Counsel: Melody Ashworth reported that Pam Vavra has requested a membership transfer to Palo Alto Meeting. Ministry & Council asks us to approve this.

**2018.2.2. South Mountain Friends Meeting lovingly approves Friend Pamela Vavra's request for a letter of transfer of membership to Palo Alto Meeting. Approved.**

Olympia Meeting will be doing a workshop on undoing institutional racism sometime during the period of March through May. They have invited Friends from the various Pacific Northwest yearly meetings to attend. Bob Morse will be attending from our meeting, so there is a possibility of ride sharing if other Friends wish to go. There is Meeting financial support available.

Ministry & Counsel also wants to

encourage participation in the Pacific Northwest Quaker Women's Theology Conference in Canby, Oregon, this coming June. Quaker women from all traditions of Friends are invited; the conference attempts to keep a balance between traditions. Patricia Morrison will be presenting at the conference.

## Building/Grounds/Joint Committee:

Herb Rothschild reported that the bathroom off the library is still out of order. The sink drain has corroded through. Steve Wells will be repairing it this week. Room rental income has picked up, so it will not be necessary to increase our monthly dues to the committee. The rule of "nothing but water" in the meeting room is an issue for some renters. Joint Committee feels that it is Joint Committee's call whether or not coffee and other drinks are brought into the room, as that committee is financially responsible for the carpet cleaning and replacement; accordingly, they are suspending this rule for groups renting the building (the rule remains in effect for Friends at this time). Joint Committee will purchase a carpet cleaner and request that renters use it on any spills they cause.

Homeless warming shelter: Crystal reported that clerk Patricia Morrison has requested that the Meeting give her permission to consult with a contract lawyer over our contract with the city of Ashland for the homeless warming shelter. Patricia is seeking the simplest way to continue to work with the shelter and protect volunteers from our Meeting. She has identified a lawyer who will give us a discounted rate. A Friend stated that he felt we should move forward but should not commit to anything without a price tag.

# Suggest Recipients of SMFM Donations, *please*

The Peace & Social Concerns Committee will decide at its meeting on the first Sunday in March which area organizations to support financially. The gifts aren't major—\$50 or \$25—but they express our appreciation of the organizations' work.

The Meeting decided several years ago to prioritize groups focused on social change rather than social service. This for two reasons: First, the only way to end the damage requiring social services is to effect systemic change. Second, social change groups have a harder time raising funds because they are often regarded as too "political." Examples of area groups we have been funding are Veterans for Peace, Health Care for All Oregon (which works for single payer), and NAMI (which among other things advocates for more mental health funding).

We do not have insurance that covers our volunteers; we have a homeowner's policy for the building, but it covers nothing off-site. Attempts have been made to find a path forward without legal assistance, but none has been found.

**2018.2.3. Meeting authorizes clerk Patricia Morrison to consult with a contract attorney regarding the city's requirement of liability coverage for our volunteers at the Ashland homeless warming shelter. Approved.**
